To create a fund you can make a one time donation, build your fund over time, donate securities or a life insurance policy, donate real estate or designate a gift in your Will (as a percentage or a set amount).

You can also can designate the community foundation as a beneficiary of a TFSA/RRSP/RRIF. Many of these options can provide a number of tax benefits to a donor's estate.
