You can give now, or give later through your estate plan. It's all about making the most of your wishes while making our community a better place.







#### What Is Planned Giving?

This resource was created for several reasons. Along with promoting philanthropy at a local level, we also want to encourage community members to seek professional advice in regards to estate and tax planning. Charitable giving can generate significant tax benefits in both annual and estate tax situations - and many people are not aware of these opportunities. For more information on these opportunities see the Charitable Gift Matrix on **pages 73 – 76**.



#### Planned Giving Or Charitable Gift Planning Happens When:

- A donor is motivated to make a donation with the belief that the values of an institution align with their own values and that these values should be preserved for the future.
- A donor works with a professional advisor to create a complete and balanced approach to giving that addresses estate, tax and financial planning objectives.

Since planned giving opportunities differ slightly in regards to charities and foundations, and because tax laws change frequently, it is recommended that those considering donations through planned giving consult a professional advisor, such as a lawyer, accountant, or financial planner. Each charity listed in this resource accepts donations through planned giving, or you can choose to make a one-time gift.

Most charities listed have a secure online option for donors. Please visit their website for more information.



#### The Many Ways to Give

Below are some simple giving options to consider. The Charitable Gift Matrix on pages 73 – 76 outlines additional giving options, and provides detailed information on the benefits to the charitable organization, the benefits to the donor, some gift examples, and the type of donor the option is most appropriate for.



#### Wills

No one wants to talk about Wills, but increasingly, forward thinking people are realizing that once they have provided for their family and loved ones, it is important and appropriate to provide for the charities they have supported during their lives. A bequest in your Will lets you do just that.

#### **Outright Gift**

Gifts of cash, securities or properties can be donated to a local charity.

#### Memorial, Testimonial, or Celebration Gift

Donations may be made in honour of an individual or an event.

#### **Life Insurance Policy**

You can donate a life insurance policy to a Charity, and pay over a period of time, or in a lump sum. Your premiums are considered a charitable donation and will earn a tax credit.

Tax receipts are issued for your donation.

#### **Discuss Your Options**

Please be sure to discuss your options with your lawyer, accountant, investment counsellor, life insurance agent, trust officer or financial planner.

In 2000, the citizens of Campbellford/Seymour changed their community forever. With foresight and wisdom, and through public discussion, the community elected to allocate the proceeds of the sale of their 100-year-old public utility to the Campbellford/Seymour Community Foundation (CSCF). The Foundation, registered as a charity in January of 2001, was then mandated to ensure that the funds were used for the common good — to benefit everyone in the community.

## Our Sole Purpose Is Building Community!

Today, the legacy of that momentous decision is the positive and lasting impact that the Campbellford/
Seymour Community Foundation is having on the community as a whole.
Community foundations develop their assets for, and in cooperation with, all the charitable causes within their community. Thus the scope of our



reach is vast and varied — arts and culture, education, youth, recreation, the environment, health, social services and community development – over \$3.5 million dollars invested since 2003!

#### So, What Does \$3.5 Million Look Like?

It looks like playgrounds, park benches, talking books, soccer nets and basketball hoops, an upgraded ball diamond, team uniforms, x-ray tables, musical instruments, forest food gardens and shade trees, a splash pad and a skate park, wetlands, waterfronts and job opportunities for youth — and so much more.

# Read on to see how we may have touched your life!







#### **Lives We Have Touched**

We like to think that the Campbellford/Seymour Community Foundation has enriched the lives of practically every resident in Trent Hills through grant funding to local organizations. Below are some examples of our broad reach and tremendous impact that may resonate with you:

#### Parks, Playgrounds and Green Spaces

You may have taken your kids to the Splash Pad or Skatepark at Kennedy Park, watched them play soccer there, walked along the Waterfront in downtown Campbellford, or used the Rotary Trail. You may have participated in "Community Build Day", helping us build three playgrounds in three communities in a single day in June 2010 or since taken your kids to one of these playgrounds in Campbellford, Hastings or Warkworth. You may have enjoyed the view over the Trent River from the gazebo at Picnic Island Park, swam and enjoyed a picnic at Crowe Bridge Conservation area, or enjoyed a hike at Ferris Provincial Park.



#### **Sports and Recreation**

You may have visited the newest municipal recreation facility in Trent Hills, the Hastings Field House. You may have worked out at the Campbellford & District Curling and Racquet Club, or curled in one of their leagues. You may have kids participate in local sports such as Campbellford Minor Hockey, The Rebels, Junior or Senior Football at the high school, or Campbellford Minor Softball. You may be a lawn bowler, or play softball or baseball at the ball diamond on the Campbellford Fairgrounds. Perhaps your children attended one of the schools in Campbellford, enjoying rejuvenated playgrounds, ball diamonds and soccer fields, as well as new recess equipment and physical education equipment.

#### **Arts and Culture**

You may have taken in a movie or live entertainment at the Aron Theatre, attended a production at Westben Arts Festival Theatre, or attended the annual Santa Claus Parade in Campbellford. You may have attended the highly successful Campbellford Incredible Edibles Festival, attended the Campbellford Fair, or Campbellford's 100th Anniversary Celebration in 2006. You may have had a child in the highly acclaimed CDHS Jazz Band, or in the Hillcrest Public School band, or in the Westben Festival Youth Chorus. You may have attended a local school production or assembly, enhanced by



new lighting, sound and wireless microphones. You may have visited the Campbellford Seymour Heritage Society to investigate historical or genealogical material, or have read or own a copy of their book on the History of the Campbellford-Seymour Agricultural Society. Your local library has many resources funded by grants as well, from the Children's Computer, the Eyewitness Series of Children's books, books on CD for Adults, to author visits. Your children may even have attended one of Artworth's excellent summer art camps.




#### **Environmental**

You may have hiked at the Seymour Conservation Area, utilizing the benches, interpretive signs and accessible privy. Your kids can now escape the sun with the permanent shade shelter at St. Mary Elementary School, or one of the portable shade shelters purchased by local schools and used for outdoor events. Kent Public School planted shade trees on their playground and regraded the hill behind the school for flood control and to prevent soil erosion, turning it into an edible classroom



with a forest food garden that will be used in the curriculum for years to come. Maybe you attended the Renewable Energy Conference and Trade Show held at Ferris Provincial Park in 2004, or were involved in the Friends of Crowe Bridge Park who succeeded in saving that conservation area so it can be enjoyed for many years to come.



#### **Jobs For Our Youth**

Your organization or an organization that you utilize may have benefited from a student working there for the summer, or you may be the student, or the parent of a student that has gained on the job experience through our Job Opportunity for Youth granting initiative. Since 2012 local organizations have applied for grant funding for summer jobs for local youth, and we fund an average of 8 positions each summer. These jobs not only give students an opportunity to develop skills for future employability, but also to learn about charitable and not-for-profit organizations and the important work they do in our community.

#### **Education**

Your children may have attended Beehive Daycare or one of the schools located in Campbellford, who have all received funding for technology upgrades such as computers, smartboards, and tablets. Maybe you learned about an event on one of the digital signs at Hillcrest Public School, or Campbellford District High School. Hillcrest and St. Mary Catholic Elementary School also have created outdoor classrooms with grant funding, so your kids can enjoy the fresh country air while learning. Maybe you have taken a computer course at the Campbellford Community Resource Centre, or participated on one of our networking events called People, Partnerships and Possibilities.





#### **Citizens In Need**

You may have had a family member utilize The Bridge Hospice in Warkworth for palliative care, or had a child benefit from a tutoring program for students with learning disabilities. You may have used the Fair Share Foodbank, or taken a nutrition course or participated in a community kitchen through the Foodbank. You many have used the Venture Van for transportation, or used one of the many services provided by Community Care or Community Living. Maybe you attended a Palliative education and support program, or a Senior Years Family Education Day, or used the Seniors Wellness Road Map to locate services in Trent Hills.



#### **Health and Wellbeing**

If you have visited Campbellford Memorial Hospital, you have been touched by the community foundation. An Accessibility Audit, Energy management study, lighting redesign and retrofit, marketing campaign for physician recruitment, and a communications strategy have all been funded by grants from the community foundation. The x-ray table was partially funded in 2005, and more recently new hospital equipment such as the digital mammography machine, was purchased through funds raised through the Flourish Campaign and are some of our largest investments in community wellness. The Independent Order of Odd Fellows Humanitarian Services lend medical equipment to community members, and grant funding allowed them to add storage space and a repair shop to their building.



### **Accessibility**

If you have visited the municipal office, the town pool, or Campbellford Memorial Hospital you have experienced improved accessibility to these facilities due to CSCF grants. St. John's United Church Auditorium and the Aron Theatre both have received grants to upgrade their door systems, and the Royal Canadian Legion, Masonic Hall, and Lions Park Beach all have upgraded their washroom facilities to become more accessible. Ferris Provincial Park now has a Debug all-terrain wheelchair, allowing people with disabilities the opportunity to enjoy their trails, picnic areas and outlook points. Community Living Campbellford/Brighton and the Campbellford Community Resource Centre received grant funding to create a state-of-the-art conference centre in their facility, and it was named The Acorn Room, in acknowledgement of the CSCF funding. It is almost always fully booked, for all kinds of uses, from Tai Chi classes to meetings, workshops and conferences.





#### **Community Development**

The Campbellford Rotary Club was instrumental in the conception of the Ranney Gorge Suspension Bridge leading to Ferris Park, and the landscaping of the west entrance to the bridge was funded by a grant. Downtown Campbellford looks more attractive, both summer and winter, thanks to grants to the Campbellford BIA for banners and Christmas Wreathes mounted on the light standards each season. The Rotary Club also purchased a boardroom table and chairs with grant funding, improving the space at the Rotary Hall to make it more useable for



community groups. Trent Hills Community Policing received grants to improve the services they provide to the community, including surveillance cameras for the public library and the town pool.



#### **Municipal Projects**

The Municipal Fund at the CSCF is used for projects determined by the Municipality of Trent Hills. Your Trent Hills Fire Department has benefited from funding for a compressor and for breathing apparatus. Signage has also been improved, from the small directional signs leading to the library, to an educational heritage sign about Rice Growing on the Trent River, to a large sign for the business park. Booth Street, leading to Campbellford Memorial Hospital, and Petherick's road were both upgraded through municipal fund grants. The clock at the Clock Tower Cultural Centre (formerly the old town hall), was restored in partnership with the Lions Club of Campbellford. CSCF and the Municipality have enjoyed a productive and mutually beneficial relationship over the past 15 years, partnering on many projects with grant funding, such as the Revitalization of Kennedy Park, Downtown Waterfront revitalization, and recreation re-development through Flourish - The Trent Hills Wellness Campaign.

## HATCH (Helping Assure Tomorrow's Charitable Hearts) Grants

Hatch grants are used to develop projects that students determine are important to them and their school. As a parent, teacher, or student, your school community has benefited from annual \$1,000 HATCH grants for projects such as litterless lunch kits, recycling stations, after school games clubs, recess play equipment and even math textbooks. Larger items like school benches, a juke box for the cafeteria and a TV monitor for school news and events were chosen by students in workshops facilitated by our YAC members.





### **Community Leadership and Partnership**

The Campbellford/Seymour Community Foundation participates actively in community partnerships, leads by example and fosters community leadership. Here's how we do it:

#### **Youth Advisory Council**

In 2003 the Community Foundation set up a Youth Advisory Council (YAC), which gives local youth a voice in their community. The YAC is made up of Campbellford District High School students, who give back to their community through events they organize such as the Earth Day Cleanup, Halloween for Hunger, and the Christmas Toy Drive. YAC members



gain leadership skills through their help facilitating our HATCH (Helping Assure Tomorrow's Charitable Hearts) grant program in the local schools. We are very proud of our community youth!



#### Peer Leadership Awards at our local schools

Each year the Community Foundation presents Peer Leadership Awards to deserving Campbellford students, nominated by their peers, for demonstrating outstanding leadership skills, at each school's year-end assembly. These leadership certificates are personalized, with the

reasons for the nomination printed on the back of the certificate, so that each student realizes the impact their actions have on those around them.



The Revitalization of Kennedy Park began in 2008, when the Municipality of Trent Hills received a Municipal Fund grant from the Community Foundation to hire a consultant to create a master plan for the

revitalization. The plan would have three phases: the first phase was to re-allocate the soccer fields to be more conducive to soccer play, to add parking spaces, and to build a state-of-the-art skatepark.

The second phase would see the creation of a vibrant playground for young people and adults alike, which ended up expanding across three communities. Our "Community Build Day" was held on September 4th, 2010, and three playgrounds - in Campbellford, Hastings and Warkworth - were completed in a single day with help from three hundred community volunteers!

The third phase focused on the addition of a spectacular splash pad. We continue to be inspired by the members of our community who provided gifts and who participated in this extraordinary revitalization project that spanned three communities, as well as with our partnership with the Municipality of Trent Hills. This has truly been a community success story!







#### A Community Garden in Campbellford

A community garden was initiated by the Community Foundation's Environmental Committee a number of years ago, and has attracted many local "green thumbs" to plant and cultivate produce for our local Food Bank. Members of the Campbellford Incredible Edibles committee took on the operation of the garden and it was renamed the Campbellford Community Edibles Garden. The Community Foundation provided grant funding to build raised beds on property on Doxsee Avenue North, owned by Newman Insurance. The garden is open to all residents and visitors to the community to stop by and pick a few vegetables or herbs to add to their meal.





#### **Citizen Of The Decade Gala**

In 2006 the Campbellford/Seymour Community Foundation partnered with the Campbellford-Seymour Heritage Society to host a gala event, called the Citizen of the Decade, in celebration of Campbellford's 100th Anniversary. Residents were asked to nominate a person they felt greatly contributed to the Campbellford community, one for each decade. The person, or member of the person's family, were presented with a special plaque, and a permanent display was installed in the Campbellford Public Library.

#### **Volunteers**

Community foundations bring together people who care about their communities. We have been blessed to have had a number of enthusiastic community members volunteer to sit on our Board of Directors, or one of our many committees, since 2001.



We are proud of our unique partnership with the Municipality and look forward to many years of continuing to work together to make a difference, in not only Campbellford/Seymour, but all of Trent Hills. A member of Council from the former Municipality of Campbellford/Seymour is a liaison between the Community Foundation and the Municipality.





### **Encouraging and Participating in Buy Local, Give Local, Live Local**

The Community Foundation requests that our grant recipients purchase goods and services for their project locally, if possible, with any grant funding they receive from us. We patronize local businesses for any of our operational expenses, from office supplies to office repair and maintenance. We are proud to support the Northumberland County Buy Local campaign, and ensure our dollars flow back into the community, which ultimately stimulates the entire community.



#### Flourish - The Trent Hills Wellness Campaign

The Community Foundation partnered with The Municipality on Flourish - The Trent Hills Wellness Campaign, a \$7 Million fundraising campaign aimed at contributing to the overall health and wellness in the Trent Hills community. The Campbellford Memorial Hospital Foundation was also a partner in this exciting initiative and succeeded in raising \$4 million for hospital equipment. The Community Foundation and the Municipality of Trent Hills continue their partnership initiated by this campaign, working on the recreation re-development initiative. (See pages 64-65). The Hastings Field House opened in 2015, and was the first phase in this initiative. The next phases include an addition of an accessible community space to the Warkworth Arena and a multi-use recreation facility with an indoor pool and an arena in Campbellford.



The CSCF has also taken a leadership role in facilitating community meetings and events. You may have provided input at one of our Interactive Community Inquiry's, where we asked local residents what kind of a large-scale project they would be interested in for the community. These community consultations ultimately lead to the Recreation and Wellness Centre Feasibility Study, with the first phase of the Municipal recreation re-development initiative, the Hastings Field House, opening in 2015.

In 2016, the Campbellford/Seymour Community Foundation celebrated its 15th anniversary as a community partner and grant maker. To mark this important milestone a community consultation process took place. Donors, volunteers, board members, grant beneficiaries and professional advisors provided input through one-on-one interviews or on-line surveys, and were asked to share their views on the impact the Community Foundation has had on the Campbellford/ Seymour community. Beginning with our commitment to community vitality, we used this information to develop our five-year strategic plan.













The Campbellford/Seymour Community Foundation relies on the generosity and commitment from our community for the continued viability of the Foundation.

We work with "Community Builders" to help them realize their philanthropic goals by matching their interests and concerns with community needs. We help them find innovative and responsible ways to give their investments lasting impact.

## Meet Some Of Our "Community Builders"

#### **Ed Fone Youth Sports Memorial Trust Fund**

In 1998 the Municipality of Trent Hills received a donation in memory of Ed Fone, to provide funding support for youth sport improvements in Campbellford/Seymour. At that time the Municipality did not have a suitable project to contribute it to, and as it had been sitting idle for a number of years the Municipality received permission from Ed's wife, Ann, in 2004, to transfer the funds to the Campbellford/Seymour Community Foundation's *Ontario Endowment for Children and Youth in Recreation Fund*. (See page 63).

Ann said "Ed was very interested in youth and coached both soccer and hockey in Campbellford. Ed enjoyed and played all sports and I felt that the *Ontario Endowment for Children and Youth in Recreation Fund* was a good fit."

#### The Northumberland Arts & Crafts Association

In 2006, Anne Linton, President of the Northumberland Arts & Crafts Association, announced the closing of its operation after 28 years of service to the community. The Association donated the net profits from their shows back to the community, concentrating on supporting Arts & Culture in the area.

Anne remarked "As we were winding up our business, we found that we had a surplus of funds for which we had to find a place. After researching possible recipients, the Campbellford/Seymour Community Foundation showed us a way to use this money to continue to give back to the community in perpetuity. By setting up a special endowment fund we are able to specify that the interest from the fund can be earmarked for those applications that pertain to the arts. This was the perfect answer for our organization. We could wind down our activities and yet still be able to meet our mandate."

Cathy Redden, 2006 CSCF President, said at that time "We are pleased and honoured that the Northumberland Arts and Crafts Association have established this endowment fund with the Community Foundation. What this fund will contribute to the Community in the future will be representative of the good work that has been accomplished by the association in the past." This is the first named Endowment Fund created with a donation from another organization. (See page 29).

#### **Campbellford Gymnastics Club**

In 1975 Marion Seguire and Gwen Carlaw started teaching gymnastics through the Recreation Department and in 1983 formed the Campbellford Gymnastics Club.

After 30 years of coaching, Marion, Beverly Meyers and Sharon Vanden Tillaart decided to retire from the club. Due to a lack of coaching staff, the Club could not continue and sold their equipment. In 2008 they donated the proceeds of \$4,500 to the Revitalization of Kennedy Park Project. (See page 16).

"It has been a local home grown program for 33 years" said Marion Seguire "which will now assist a new recreation project in our community." 



#### **Program Statement**


It is our belief that every family has the right to high quality childcare in a positive and stimulating environment.



# Wellness and Recreation Centre in Campbellford

The Wellness and Recreation Centre in Campbellford will be a facility that provides a broad range of services – an aquatic facility with a lane pool and a therapeutic pool, a new arena, and meeting rooms with a kitchenette. The pool will serve all kinds of recreation needs, such as swimming lessons, aquafit programs, therapy programs, lane swimming and competitive swimming. The benefits of combining an aquatic facility with an arena include recovering waste heat from ice rink operations as a method of pool heating, making the facility more energy efficient.





# Warkworth Arena

The addition to the Warkworth Arena will contain additional dressing rooms, multi-purpose rooms and a kitchen, providing the Warkworth community with a fully accessible facility for community use.



Origins of the Northumberland United Way date back to 1966 when a group of local businessmen, with the assistance of the Chamber of Commerce, started investigating the possibilities of establishing a United Appeal in Cobourg.
